Dear Mr. Brooks:

Enclosed is Nebraska's State Implementation Plan (SIP) for Regional Haze and Best Available Retrofit Technology (BART) pursuant to the requirements of 40 Code of Federal Regulations (CFR) 51.308(a)-(e). The enclosed SIP addresses Regional Planning, State/Tribe and Federal Land Manager coordination as well as a commitment to provide future plan revisions and adequacy determinations.

The state of Nebraska does not contain mandatory Class I areas. However, we have coordinated with the Central Regional Air Planning Association (CENRAP) in an effort to improve visibility at Class I areas included in the CENRAP states, as well as nearby States outside the CENRAP region. Nebraska installed two IMPROVE protocol samplers, one in the central part of the state and another in the Nebraska panhandle. In addition, the Omaha Tribe of Nebraska operates a third IMPROVE sampler in the northeast part of the state. The information from these samplers as well as data obtained by CENRAP were utilized in the development of the enclosed SIP, including detailed analyses, modeling results, and technical support documents.

On February 16, 2008, Nebraska adopted Chapter 43 – Visibility Protection into Title 129 of the Nebraska State Code, the Nebraska Air Quality Regulations. Chapter 43 of Title 129 incorporates the Regional Haze Rule by reference and requires owners or operators of stationary sources subject to BART to prepare and submit a BART determination in accordance with the Regional Haze Rule. A public hearing was held on January 21, 2011 for the Regional Haze and BART State Implementation Plan. The SIP was adopted by Nebraska per Title 115, the Nebraska Administrative Procedures Act, and in accordance with 40 CFR 51.100 – 105.

As evidenced by the enclosed State Implementation Plan and the appendices, the Nebraska Department of Environmental Quality (NDEQ) conducted a thorough

evaluation of all available data in the determination of sources that are subject to the requirements of BART. With this submission, the NDEQ is requesting that the United States Environmental Protection Agency (EPA) accept the Nebraska Regional Haze and Best Available Retrofit Technology (BART) State Implementation Plan to satisfy the requirements of 40 CFR 51.308(a)-(e).
