- B. By September 1, 2014, the Respondent shall begin construction on the upgrades to the wastewater system in accordance with the approved plans and specifications.
- C. By October 1, 2015, the Respondent shall place in operation a wastewater system which is in compliance with the statutes and regulations.
- 21. The Parties agree that necessary funding for the project shall be secured by the Respondent by March 1, 2014.

22. The parties agree that the Respondent shall submit quarterly written progress updates to the Department. "
