### I. INTRODUCTION

- 1. This Complaint, Compliance and Notice of Opportunity for Hearing is issued pursuant to Neb. Rev. Stat. §§ 81-1504 and 81-1507 by the Director of the Nebraska Department of Environment and Energy (Department).
- 2. The Respondent is Bruce Doerr who resides at 53689 Highway 59, Creighton, Knox County, Nebraska 68729.
- 3. This Compliance Order establishes a schedule of corrective actions necessary to achieve and maintain compliance with the Nebraska Environmental Protection Act (NEPA), Neb. Rev. Stat. §§ 81-1501 to 81-1532 (Reissue 2014; Cum. Supp. 2018) and all rules and regulations promulgated under such Act.

## II. STATUTORY AND REGULATORY SETTING

- 4. Pursuant to Neb. Rev. Stat. § 81-1505(1) and (8), the Nebraska Environmental Quality Council adopted a rule and standard codified as Neb. Admin. Code Title 124 Rules and Regulations for the Design, Operation and Maintenance of Onsite Wastewater Treatment Systems.
- 5. Title 124, Ch. 1, <u>035</u> defines failed or failing as an unauthorized discharge of effluent or wastewater: on the surface of the ground; or to a cesspool, seepage pit, dry well, or leaching pit;



or to a soil absorption system with less than four feet to groundwater or other limiting soil characteristics; or which threatens to cause pollution of any air, water, or land of the State; or which threatens public health.

- 6. Title 124 Ch. 1, <u>061</u> defines an onsite wastewater system as "any system of piping, treatment devices, or other appurtenances that convey, store, treat, or dispose of domestic or non-domestic wastewater...on the property where it originates, or on nearby property under the control of the user, which system is not connected to a public sewer..."
- 7. Title 124, Ch. 2, <u>007.03</u> prohibits the discharge of domestic wastewater from a dwelling or an onsite wastewater system to the land surface without Department approval.
- 8. Title 124 Ch. 3.<u>008</u> prohibits the operation of an onsite wastewater system if the system has failed, endangers public health or results in a prohibited discharge.
- 9. Neb. Rev. Stat. § 81-1506 makes it unlawful to cause land or water pollution or to cause to be placed any wastes in a location where they are likely to cause land or water pollution or to operate any disposal system without obtaining the necessary permits from the Department.
- 10. Pursuant to Neb. Rev. Stat. §81-1507, the Director may order necessary compliance actions be taken in response to the violations alleged within a reasonable time as described in Section IV, below.

### III. COMPLAINT

- 11. Respondent discharges domestic sewage through an onsite wastewater system located at 53689 Highway 59, Creighton, Knox County, Nebraska 68729.
- 12. On or about April 2, 2018, the Department received a complaint regarding an open sewage discharge coming from Respondent's septic system onto adjacent property. The

Department followed up the complaint by sending a letter via certified mail requesting the Respondent voluntarily cease the discharge and correct the problem.

- 13. On or about April 22, 2018, the Department received an email response from Respondent describing a plan to have the system repaired within 120 days.
- 14. On or about November 27, 2018, the Department sent the Respondent a letter of warning via certified mail requesting that Respondent provide the Department with written documentation that the wastewater system comply with Title 124 requirements.
- 15. On or about May 29, 2019, the Department sent the Respondent an email reminding him that of the required upgrades and requesting a response by June 19, 2019, which the Department has not received.
- 16. On or about October 22, 2019, Department staff conducted a site inspection of Respondent's onsite system and observed open sewer discharge onto the land surface in the area west of the house and tree line. Department staff were unable to contact the Respondent's during the site visit because of barking dogs in the driveway and yard of the house.
- 17. Respondent owns a failed onsite system and is discharging wastewater onto the land surface in violation of Neb. Rev. Stat. § 81-1506 and Title 124, Ch. 2, <u>007.03</u>.

## IV. COMPLIANCE ORDER

- 18. It is hereby ORDERED that Respondent shall:
  - a. By December 20, 2019, have his wastewater system inspected and repaired or replaced by a certified professional authorized to engage in such activities or connect the residence to the city sewer system.

b. By January 17, 2020, provide the Department with documentation that his wastewater system comply with Title 124 requirements. Documentation shall be sent to the attention of:

19. Respondent shall reply to the above address or email within seven (7) working days to all requests for information.

## V. NOTICE OF OPPORTUNITY TO REQUEST A HEARING

- 20. This Order shall become final, pursuant to Neb. Rev. Stat. § 81-1507(1), unless the Respondent files an answer and requests, in writing, a hearing no later than thirty days after receipt of this Order. Failure to answer within thirty days shall be deemed an admission of the allegations of the Complaint.
- 21. A written answer to the Complaint, Compliance Order, and Notice of Opportunity for Hearing must conform to the requirements of Title 115, Neb. Admin. Code, *Rules of Practice* and *Procedure*, Chapter 7. The answer and request for hearing may be filed by mail to:

### VI. SETTLEMENT CONFERENCE

22. Whether or not Respondent requests a hearing, an informal settlement conference may be requested by writing to Thomas O'Connor, Attorney, Nebraska Department of Environment and Energy, P.O. Box 98922, Lincoln, Nebraska 68509-8922, or have your attorney make such a request. A request for settlement conference does not extend the thirty (30) day period during which a written answer and request for hearing must be submitted or otherwise delay the final effective date of this Order.

### VII. RESERVATION OF RIGHTS AND PENALTY PROVISIONS

23. The Department reserves the right to require the Respondent to complete additional work or take additional actions as necessary to achieve compliance with all applicable laws and regulations. Further, the Department reserves the right to pursue enforcement in the proper court of law for injunctive relief or to seek civil or criminal penalties for any violations that are the subject of this Complaint, Compliance Order and Notice of Opportunity for Hearing. Nothing in this Complaint, Compliance Order and Notice of Opportunity for Hearing precludes the Department from pursuing such enforcement.

24. Failure to comply with this Compliance Order may result in fines or penalties up to \$10,000.00 per day with each day of violation constituting a separate offence, as set out in Neb. Rev. Stat. § 81-1506.
