Re: Annual "Needs Survey" for Clean Water (Wastewater) Projects
Clean Water State Revolving Fund (CWSRF)

Attached please find our annual "Needs Survey". We're asking you and every community in Nebraska about their Wastewater Infrastructure or Nonpoint Source Control (such as Watershed Improvement Projects) needs. Filling out this survey helps us to present the best possible information on state and national funding needs to decision makers, including our state legislature, the U.S. Congress, and the Environmental Protection Agency.

Filling out this survey in no way commits you to undertaking a wastewater project or signing a Clean Water State Revolving Fund (CWSRF) loan.

The information you supply us will be used to develop the Intended Use Plan, which includes the potential publically-owned projects (as identified from the Needs Survey) across the state. We encourage you to seek assistance from your Engineer or Consultant. Facility planning grants can be funded from the Intended Use Plan, as well as infrastructure loans. For consideration of a clean water planning grant be sure to include it in the project description portion of the Needs Survey. Currently, the effective interest rate on 20-year loans from the CWSRF is 1.5% + 1% administration fee.

"Green Infrastructure": In the past, we have used ~20% of our annual capitalization grant to fund Green Infrastructure projects. Examples of Green Infrastructure projects include energy efficiency improvements, stormwater management or reuse, water efficiency (such as water consumption meters), or environmentally innovative activities. Portions of projects may qualify as Green Infrastructure. Currently, Green Infrastructure loans have an interest rate of 1.25% +1% administration fee to help encourage this concept.
